1. They will be paid remuneration as per the outsourcing policy of Haryana Government.
2. Initially, they are engaged for a period of one year or till the candidates duly selected by Haryana Staff Selection Commission are available for regular appointment on these posts, whichever is earlier.
3. This engagement shall not confer any right to the candidates for regularization in service or any other benefits for any such purpose.
4. In case the work and conduct of any contractual Lab Technician so engaged is found unsatisfactory during the period of engagement, his/her services shall be terminated without serving any notice.
5. The posting shall be non-transferrable and non-interchangeable.
6. The selected candidates before joining in the department will have to execute a written agreement between the candidate and the concerned Deputy Director (AH) of the district on behalf of Government of Haryana. The format of agreement is available on the departmental website "<http://pashudhanharyana.gov.in>".
7. In the eventuality of regular appointments of Lab Technician through HSSC on these posts, the services of these candidates shall be terminated with immediate effect without serving any notice.

The candidates who are willing to accept the above terms and conditions should report for joining the duty to the Deputy Director, Animal Husbandry and Dairying/ Intensive Cattle Development Project, of the concerned district within 15 days from the issue of this order. If any candidate fails to report for joining within the stipulated period of 15 days, his/her right to join on this post shall be forfeited.
