2. On careful consideration of the report, the Governor of Haryana, fully agrees with the conclusions reached at by the Inquiry Officer in respect of the charges levelled against you and holds that these charges stand proved. It has been observed that you have been abdicating your official duties willfully. Hence, the Governor of Haryana is provisionally of the opinion that a penalty of compulsory retirement w.e.f. 28.2.2010 be imposed upon you. However, before doing so, it has been desired to afford you an opportunity of showing cause as to why the action proposed not be taken. Any representation which you may like to make in that connection will be considered before taking the proposed action. Such representation, if any, should be made in writing and submitted to the undersigned so as to reach not later than 21 days from the receipt of this communication by you.
