On the recommendation of Haryana Staff Selection Commission, Panchkula against Advt. No. 15/2019 Category No.11 conveyed vide their letter No. HSSC/Confid./Recomn./2022/126 dated 21.02.2022 and HSSC/08/02/2022-9CA-5017 dated 07.11.2022 the following candidate is hereby appointed as Veterinary Livestock Development Assistant (VLDA) in the Department of Animal Husbandry & Dairying on temporary basis in the Functional Pay level-6 in pay matrix Rs. 35400-112400 plus usual allowances sanctioned by the Haryana Government from time to time subject to the terms and conditions contained in this letter.

Terms and Conditions:

1. You are appointed purely on temporary/provisional basis.
2. Your appointment is against temporary post and confirmation against substantive post will be considered on the basis of your seniority and record of service as and when such post will be available.
3. You will be on probation for a period of two years from the date of joining of your duty which can be extended, if necessary, up to three years. In case your work and conduct during the probationary period is not found satisfactory, your services will be terminated at any time without any notice or reasons being assigned thereof. If, however, you wish to resign at any time from the post, you will have to give one month's notice or deposit one month's salary and allowances.

You are required to furnish a Medical Certificate of fitness for first entry into Government service from the competent medical authority as per rule 9 of Haryana Civil Service (General) Rule 2016. 8. You will be governed by Haryana Veterinary Headquarter and field (Group C) Service Rules, 1999, amended on 28.02.2011 or will be amended from time to time or relevant rules and instructions issued by the State Government from time to time.
9. No TA/DA will be admissible to you for journey undertaken for joining.
10. Your seniority will remain the same as has been determined by the Haryana Staff Selection Commission, Panchkula or as per Law provided in Service Rules.
11. You will be covered by the "NEW DEFINED CONTRIBUTION PENSION SCHEME" as per FD notification dated 28.10.2005.
12. Although the office has taken every care while issuing this appointment letter, even then if any unintended error comes into notice of this office at a later stage, this office reserves the right to rectify/correct it accordingly.
13. Further this appointment is subject to the final outcome of CWP No. 15967 of 2021, 19709 of 2021, 1407 of 2022, 2493 of 2022, 2521 of 2022, 2667 of 2022, 3069 of 2022, 3288 of 2022 pending in Hon'ble Punjab and Haryana High Court, Chandigarh or any other case in any court.

The candidate Anoop selected at Merit No. 229 bearing Roll No. 18110296 has filed the writ petition 19893 of 2021, so the merit of the candidate may change and new merit No. of the candidate may be decided after the decision of the writ petition CWP No. 2493 of 2022, 2521 of 2022 and 2667 of 2022.
15. Further this appointment is subject to the compliance / decision of the competent authority on the orders passed by Hon'ble Punjab and Haryana High Court, Chandigarh in CWP 20762 of 2021.

In case you accept the offer of appointment as Veterinary Livestock Development Assistant on terms and conditions mentioned above, you should report for joining your duties in the office of Deputy Director, Animal Husbandry & Dairying, Mahendergarh within 30 days from the date of issue of this order with medical fitness certificate issued by the concerned Chief Medical Officer (District mentioned in address of candidate or district of work allocation), failing which this appointment will stand cancelled.

This appointment order is issued without prejudice to the powers of the appointing authority to make rectification including cancellation of appointment, in case any discrepancy is noticed in future.
