**ORDER**

**Subject: Performance of clinical work by the Haryana Veterinary Services (Group A and B) doctors posted at various posts other than Government Veterinary Hospitals/Polyclinics.**

In the interest of improving veterinary service delivery mechanism to the valuable livestock of the State, availing benefit of vast clinical experience of Veterinary Clinicians available with the Department up-to optimum level, and to meet out the shortage of Veterinary Surgeons, all the Veterinary Clinicians of Haryana Veterinary Services (Group A and B) posted in various institutions/offices shall perform clinical work in Government Veterinary Hospitals/Polyclinics as prescribed below-

Sr. No.	Name of the Post	Period
1.	Director General, Animal Husbandry/ Managing Director, HLDB/ Officer on Special Duty, Animal Husbandry or any equivalent post	One day in a week (for two hours)
2.	Joint Directors or equivalent rank Officers posted in the office of DGAH/HLDB/any other institutions/offices	One day in a week (for two hours)
3.	All Deputy Directors or equivalent rank Officers posted in the office of DGAH/HLDB/ Haryana Gau Sewa Aayog, Haryana Veterinary Council or any other institutions/offices	One day in a week
4.	Sub Divisional Officers or equivalent rank Officers posted in the office of DGAH/HLDB/any other institutions/offices	Two days in a week
5.	All Veterinary Surgeons or equivalent rank Clinicians posted in the office of DGAH/HLDB, any other institutions/offices	Two days in a week

2. No Veterinary Doctor/Clinician belonging to the afore-mentioned services regardless of his posting in any offices of the State, including the doctors working on deputation within the State of Haryana will be exempted from performance of clinical duties as prescribed above.
3. In case a doctor is not able to perform the clinical duty for any reason including administrative exigencies, he/she will make up for that by doing additional work in the following weeks.
4. The above mentioned doctors will have the options to choose an institution of their choice for discharging clinical duties. The institution once opted can be changed with the prior approval of the Director General, Animal Husbandry & Dairying. However, it is expected that the opted institution shall not be changed frequently.
5. Director General, Animal Husbandry & Dairying shall devise a mechanism for keeping a record of the clinical duties performed by all the doctors. Non performance of clinical

duties in the manner prescribed will be held against the doctors while considering their cases for various service benefits including promotion. Due TA/DA as per rules will be admissible when clinical duties are performed outstations.

6. The day a Veterinary Doctor/Clinician does not perform clinical duty or does not make up in following weeks, will be treated as absence from duty.


7. No exemption will be granted to the doctors posted in Haryana Livestock Development Board/Haryana Gau Sewa Aayog/ Haryana Veterinary Council or any other similar institution/office.

8. These instructions will come into force with immediate effect. Director General, Animal Husbandry & Dairying will report compliance within 15 days. Inspection report shall be prepared and sent every week.

9. All the Veterinary Clinicians shall be obliged to offer Consultation by Tele-Medicine whenever required.


