On the recommendation of the Haryana Staff Selection Commission, Haryana, Panchkula vide Letter No.HSSC/Confd/ Recomm/ 2019/737, dated 08.11.2019 you are hereby appointed as Steno Typist (Both Languages) in the Department of Animal Husbandry & Dairying, Haryana on purely temporary basis in an officiating capacity in pay scale FPL-2 of Pay Matrix plus allowances as admissible as per State Govt. Rules notified from time to time on the following terms and conditions:-

- You will be on probation for a period of two years from the date of joining your duty. In case your work and conduct during the probationary period is not found satisfactory, your services will be terminated at any time without any notice or reasons being assigned thereof. If, however, you wish to resign at any time from the post, you shall have to give one month's notice or deposit one month's salary and allowances.
- ii) You are required to furnish a Medical Certificate of fitness for first entry into Government service from the Chief Medical Officer of the concerned District under rule 3.1 of CSR Vol-1, Part-1. In case you are not declared medically fit by the Chief Medical Officer to whom the directions are issued for medical examination, you will not be allowed to join the service and your offer of appointment will be treated as null and void.
- iii) Your appointment is subject to the verification of your educational qualification/ experience/age/caste/cat./eligibility of sports gradation/PH/ESM etc. In case it reveals that you do not fulfill the requisite qualification or you have submitted

wrong certificate (s), your service will liable to termination without any notice and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.

- iv) You will be governed by the Haryana Veterinary Headquarter and field (Group-C) Services Rules, 1999 as amended by the State Government from time to time.
- v) Your character and antecedents have not been got verified and in case subsequently anything adverse comes to the notice of the State Govt./Department regarding your character and antecedent, your services will liable to be terminated without any notice.
- vi) You will be required to pass the State Eligibility Test in Computer Appreciation and Applications (SETC) including type test within the probation period of two years, extendable by one year in case of direct recruitment, if you do not qualify the above said test, you will not be entitled to earn any increment in your pay scale till you qualify the above said test within the stipulated time as above, failing which your services shall be dispensed with immediate effect.
- vii) No TA/DA will be allowed from the place of your residence to the place of your posting.
- viii) Your seniority will remain the same as has been determined by the Haryana Staff Selection Commission, Panchkula, further subject to Government rules/instructions.
- You will have to furnish a certificate to the effect that you have not more than one wife living (if you are married).
