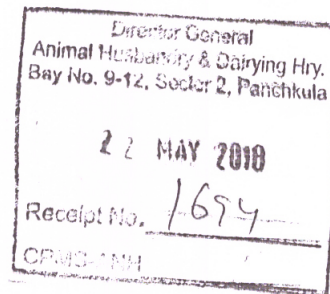

Subject:- Special Livestock Insurance Scheme (SCSP) for the year 2018-19.

Ref. Your memo No. 2866 P-6, dated 26.04.2018

The Governor of Haryana is pleased to accord administrative approval-cum-financial sanction to the continuance of the scheme cited as subject during the year 2018-19 on non-recurring basis at a total estimated cost of Rs 75.00/- lacs (Rupees Seventy Five lacs

Lacs only) for First installment as per enclosed statement of cost subject to the following

conditions:-

- i) Scheme is approved in the budget Estimate of the department.
- ii) No new post will be created under the scheme and no vacant post would be filled up without prior approval of Finance Department.
- iii) The expenditure of the year will be passed out in four quarters viz 1st quarter 25%, 2nd quarter 20%, 3rd quarter 25% and 4th quarter 30%.
- iv) Instruction on economy measures issued by the Finance Department from time to time will be strictly adhered to.

Quarterly physical targets (District wise) for regular monitoring for all the three schemes (Milch Animal, Piggery and Sheeps raising) will also be indicated.

2. The revised sanction will be issued in case the provision of this scheme is modified at any stage.

3. The expenditure involved will be debited to the head :-

Subject:- Special Livestock Insurance Scheme (SCSP) for the year 2018-19.

Memo:

It is a continued scheme, which is proposed to be implemented in the State during the year 2018-19 also. The scheme in principle stands approved by the Government in the State Budget for the year 2018-19 for which an amount of Rs. 3.00 crores is earmarked for this scheme. The detail of the scheme and basic data of livestock is as under:-

BASIC DATA OF LIVESTOCK AMONG SCHEDULED CASTE FAMILIES:

According to the livestock census 2012, about 22.27 lac families are rearing one or other type of livestock in the State out of which 8.86 lacs are Scheduled Caste families who are generally resource poor. Occupation wise, out of a total 8.86 lacs Scheduled Caste families, 44% exclusively depends on Animal Husbandry & Agriculture and 56% on other sectors including service sector. Out of total livestock population in the State, Scheduled Caste families possess 23% of the livestock although of low genetic merit. Scheduled Caste families contribute substantively in the Animal Husbandry sector and it is the major occupation of these families.

The trend of rearing of livestock species by Scheduled Caste families in the State as per livestock census 2012 is given in the following table:-

Species	Total (in lac no.)	Owned by SCs (in lac no.)	Percentage
Bovine (Buffaloes/cows)	78.93	12.35	16.30
Goat	3.69	2.84	61.74
Sheep	3.63	4.60	72.67
Pigs	1.27	0.99	82.50
Total	87.52	20.78	23.65

The above table shows that out of the total livestock population in the State, 60 to 80% of Sheep, Goat and Pig are reared by Scheduled Caste families whereas milch animals only 16%.

This scheme is for the benefit and the welfare of the Scheduled Caste families engaged in rearing of livestock. This Special Livestock Insurance Scheme for Scheduled Caste families will be available throughout

the State. Insurance of the animals of livestock units established under the 'Scheme for Providing Employment Opportunities to Scheduled Castes (SCSP)' being implemented by the Department by establishing livestock units i.e. dairy, piggery, sheep and goat units, will also be done free of cost under this scheme. Besides insurance of animals of established units as mentioned above, milch buffalo, milch cattle, sheep, goat, pigs, pack animals (mule, horse, ponny, donkey) and camel would also be insured free of cost under the scheme-

Publicity of the scheme



A wide publicity of this scheme is to be made for which a minimum sum of Rs. 25,000/- per district totaling to Rs. 5.50 lac for the year 2018-19, is proposed and this amount will be borne by the State Government under the scheme.

The entire cost of insurance premium, publicity expenses and honorarium to Veterinary Surgeons will be borne by the State Govt. under the scheme. Honorarium @ Rs. 50/- for issuance of health certificate and @ Rs. 100/- on post-mortem certificate will be provided to the Veterinary Surgeon.

The expenditure involved shall be debited to the budget grant under head: -
