

## ORDER

On the advice of Haryana Staff Selection Commission, Panchkula vide letter No. HSSC/Confid./Recomn./2012/411 dated 18.07.2012, the six waiting candidates of General Category as shown in enclosed list are hereby given appointment as Veterinary Livestock Development Assistants in the department of Animal Husbandry & Dairying on regular basis in the pay scale of Rs. 9300-34800 + 3200 GP Plus usual allowances sanctioned by the Haryana Government from time to time. The order are being issued in view of the non-joining of the Six General Category Candidates out of the total 136 recommended Candidates for selection.

If the offer is accepted, he should report for joining his duty at the place of posting mentioned against each, through the concerned Deputy Director of the Distt. within 15 days from the date of despatch of this order, otherwise this appointment will stand cancelled.

### His appointment is further subject to the following conditions:-

1. He will be on probation for a period of two years. In case his work and conduct during this period is found unsatisfactory, his service is likely to be terminated without any notice.
2. After completion of probationary period satisfactorily, his appointment as such will be liable to be terminated by giving him one month notice or paying him wages for any period by which such a notice falls short of one month. If he intends to resign the post, he will have to deposit one month's pay and allowances for the period the notice given by him falls short of one month.
3. He has only one living wife, if married.
4. He produces a Medical Certificate of fitness for first entry into Government service from the Chief Medical Officer of the concerned District (Documents Attached).
5. His character and antecedents have been duly verified. In case any of the adverse fact come to the notice of the State Government / Department regarding his character and antecedents, his services will be liable to be terminated.
6. **It is further conveyed that once the recruitee is joined at the place of posting he will not be shifted in any case to new place during his probation period of two years.**
